# Admiral Michael Rogers Former Director, National Security Agency and Former Commander, US Cyber Command

Admiral Michael Rogers is the former director of the National Security Agency, the former chief of Central Security Service and the former commander of United States Cyber Command. He served under both Presidents Trump and Obama and oversaw the NSA and Cyber Command responses to both the Snowden leaks and Russian interference in the 2016 U.S.

presidential election. He also put the NSA through is largest reorganization in 20 years and led the creation and operationalization of the nation's cyber mission force, culminating in the elevation of Cyber Command to the senior-most command level in the Department of Defense.

#### The Shifting Cyber Security Threat Landscape

As the second-ever commander of U.S. Cyber Command, Admiral Michael Rogers was instrumental in building up the capacity and capabilities of the agency, now a combatant force of hackers, analysts and staffers all focused on America's most-pressing cyber security challenges. Here, Rogers offers a window into the role he played in the formation of U.S. cyber policy and practice, and answers questions like these:

- How can organizations keep their systems secure in the 21st century?
- What actors should we be worried about, and how ought we to respond to a crisis?
- What are the defensive and offensive strategies groups should employ?
- How will America stay ahead of the cyber security curve?

Offering both a technical perspective and a policy perspective that looks at pertinent issues domestically and globally, Rogers argues for an allied government, industry and private sector approach to ensure American prosperity and peace.

# **Getting Paid and Protecting Your Business**

This session will provide an overview of key contract terms that affect liability and payment terms. While the vast majority of the language in a contract is devoted to outlining the allocation of liabilities and various requirements for payment, few contractors have a developed understanding of those terms or their implications because most projects proceed without a dispute occurring, and therefore the exact language of the contract is never enforced. But once a dispute has occurred, it's too late to consider the implications of these important terms for the first time. This presentation will explain what these terms mean and how they operate from a legal perspective.

# Designating an OSHA Competent Person: What You Need to Know

According to the U.S. Occupational Safety and Health Administration, a "'[C]ompetent person' means one who is capable of identifying existing and predictable hazards in the surroundings or working conditions which are unsanitary, hazardous or dangerous to employees, and who has authorization to take prompt corrective measures to eliminate them" (29 CFR 1926.32(f)). However, this definition (like many others) can be subject to interpretation. Furthermore, certain OSHA standards have very specific requirements describing the duties of a competent person, while others make only a passing reference to competence.

How to make sense of it all—and make sure you're in compliance with OSHA standards?

The **Catamount Consulting Team** has spent a great deal of time exploring the foundations of this standard to better help construction professionals understand just what OSHA expects on the job site. Attendees are invited to join in this session to discuss the ins and outs of the competent person requirements as they relate to OSHA's construction standards, as well as learn how to ensure compliance with OSHA standards.

Two high-demand topics with a twist. AWCI is condensing two Doing It Right seminars (gypsum and exterior envelope) into one for this one-time presentation. Meeting the demands brought on by more stringent regulations that focus on new performance requirements has made achieving a successful project in our industry even more challenging. Understanding the fundamental basics of these codes and the building science behind them is essential. systems, which are substantially more sophisticated than what was designed and built just a few years ago. Sophisticated high performing wall systems rely heavily on proper detailing and installation. This course starts with codes and standards, discusses the underlying building sciences, and ends with information for the job site with a goal to make a project successful.

**Robert Grupe**, AWCI's director of technical services, spent more than 38 years with United States Gypsum Company where he held various technical

and management positions. Activities included product and system design and technical consultation to the AEC community. He currently is a consultant to the construction community where he has worked on several large scale international construction projects. He has authored numerous articles and given presentations on fire, sound and environmental issues as they relate to wall and ceiling assemblies.

### Stucco-Doing It Right®

This seminar is based on ASTM C926 and C1063 and covers the application of portland cement-based plaster applied to metal and solid bases.
